(EDL-Gen O&M) the subsidiary company of EDL-Generation Public Company (EDL-Gen) and EGCO Engineering & Service Co., Ltd. (ESCO), the leading of Thai's power plant operation and maintenance services provider. The Company established on 15 November 2018, registered share capital of the Company is 8,000,000,000 Kip which 60% is owned by EDL-Gen O&M and 40% by ESCO.



Objective

EDL-Gen O&M and ESCO have jointly set up the **E&E Engineering and Service Company Limited** for the purpose of providing operational and maintenance to 650MW Nam Theun 1 hydroelectric power generation and to provide the various services to other power plants and industries in the Laos PDR.

The EDL-Generation Public Company (EDL-Gen) was incorporated as a public company with limited liability on 15 December 2010 through a spin off from Electricite Du Laos (EDL) where EDL's generation assets were transferred to the company.

The company currently owns 10 hydropower plants, with a combined installed capacity of 1,131 MW.

EDL-Gen invests in equity shares in 5 Independent Power Producers (IPPs) with the total capacity of 512 MW and the electricity has been sold partly to EDL and EGAT.

EDL-Gen has a capitalization of 6,717 Billion Kip which 75% is owned by Electricite Du Laos (EDL) and 25% by Public. It was the first public company registered in Lao Securities Exchange (LSX) in 2011.

The Core Business Operation:

- To generate and sell (wholesale) electricity to EDL as well as construct the transmission lines and substations as necessary.
- To invest in the generation assets, which are constructed and planned by EDL or the shares wholly owned or partially owned by EDL in the EDL's IPPs.
- To provide operation and maintenance services to other power generation projects in Lao PDR.



SCOPE OF SERVICES



EDL-GEN Operation and Maintenance Service Sole Co., Ltd. (EDL-Gen O&M)

was subsidiary company of EDL-Generation Public Company (EDL-Gen) which established on 14 December 2017 that registered as legal entity in Lao PDR.

However, in terms of company's O&M engineers have been experienced more than 40 years with 10 hydropower plants including Nam Ngum 1 (COD-1971), Namkhan 2 (COD-2015), Houaylamphangnai (COD-2015), Xeset 2 (COD-2009), Nam Leuk (COD-2000), Xeset 1 (COD-1991), Nam Mang 3 (COD-2005), Namsana (COD-2014), Nam Song (COD-2012) and Selabam with total installed capacity of 619 MW.

The registered capital of the company is 2,400,000,000 Kip with shared by EDL-Gen 100%
